**PUBLIC NOTICE**

As per information received from Govt. of India,  
Attention of all concerned is drawn towards the following:-

1. All Institutes which do not have a valid AISHE/DISE codes have been deregistered from National Scholarship Portal (NSP). A provision has however been made for re-registration after obtaining valid AISHE/DISE code.
2. The Email ids and mobile numbers of all Institutes registered/stored in NSP have been deactivated. The Institutes are to fill up an online form on the portal by logging in with the existing User I.D. and Password and to get the printout authenticated in duplicate by the Head of the Institute after which they are required to submit the forms to the District School Education Officer (DSEO) of their respective districts along with a copy of the I.D. proof of the Institute Nodal Officer (Voter I.D., Aadhaar, Institute I.D., Driving License, etc.). Institutions from East Khasi Hills are to submit the same to the State Nodal Officer, DHTE, Shillong, Room No. 206A, Additional Secretariat Building. Last date of submission is 2<sup>nd</sup> September, 2019.
3. Duly authenticated online form will be returned to the Institute for record and State Nodal Officer will retain a copy. On verification, the State Nodal Officer will activate the account of the Institute on the portal. On activation, new User IDs and passwords will be forwarded to the registered mobile number of the Institute Nodal Officer. It will be the responsibility of the Institute to retain the copy received from State Nodal Officer and produce it to the appropriate authority on demand.

**Note:** The Institutes which are unable to log in using their existing User I.D. and passwords are directed to send a formal request from the Head of the Institution to this office for resetting their existing User I.D. and password by email to the following email address- [scholarshipregn@gmail.com](mailto:scholarshipregn@gmail.com) or in person during office hours.
