N.B 1. It is to be noted that as per Government Order No.EDU.167/89/47 dated 23rd March, 1990, it is specified that :-

- (a) All Schools shall strictly adhere to the Academic Calendar.
- (b) Adherence to the Academic Calendar shall be a pre – condition to the renewal of Maintenance Grants and the sanctions of all other forms of financial assistance to School under the ‘Deficit’ and ‘Adhoc System’ of Grants-inAid.
- (c) All Schools shall have a minimum of two hundred and twenty ‘effective teaching days’, exclusive of Sundays, local holidays and public holidays each academic year.

2. Higher Secondary Sections in the Colleges shall also follow the above Academic Calendar.
