EDUCATIONAL QUALIFICATION:

The candidates seeking admission should secure in aggregate the minimum of 50% marks for General Category and 45% marks in case of SC/ST Category along with the criteria given below.

Candidates who have passed 10+2 or its equivalent examination with English, Physics, Chemistry, Biology and Mathematics of a recognized University / Board. Selection of Candidate shall be made in order of merit of aggregate marks of English, Physics, Chemistry, Biology and Mathematics in the qualifying examination.

AGE LIMIT:

Candidates should not be less than 17 years and not more than 21 years of age as on 1st July 2020. The upper age limit is relaxable by 3 years in case of candidates belonging to Scheduled Tribe and Scheduled Caste.

RESERVATION:

Nomination of Selected candidates in order of merit will be made from this Office against the above seats. The reservation policy of the State Government will be applicable.

NOTE:

The Government of Meghalaya will not be responsible for providing jobs to the nominated candidates after completion of their courses.
