No.EDN.177/2018/102 : In supercession to the Notification **No.EDN.177/2018/90**, dated **04.01.2023**, **No.EDN.177/2018/92**, dated **13.01.2023**, **No.EDN.177/2018/93**, dated **13.01.2023**, **No.EDN.177/2018/94**, dated **13.01.2023**, The Governor of Meghalaya is please to allow for enhancement of general maintenance to Governing Bodies of Adhoc grant-in-Aid Colleges for meeting the expenditure on salary of teachers and non-teaching staff holding sanctioned posts in line with the recommendations of Fifth Meghalaya Pay Commission as indicated below :-

The sanction is accorded subject to the following conditions:-

- i. That the effective date of enhancement for the college listed at serial No. 1 shall be from 1st March, 2020.
- ii. That the effective date of enhancement for the colleges listed at serial No. 2 to serial No.9 shall be from 1st January, 2017.
- iii. That arrear salary in respect of employees of Colleges above mentioned listed at serial Nos.8 and 9 shall be upto 31st August, 2021, subsequent to which these colleges have been brought under Peoples' College grant-in-aid.

- iv. That the Adhoc Grant-in-Aid covers 75% of the estimated expenditure and 25% there of shall be borne by the GBs of the Colleges concerned.
- v. That the sanction is purely on adhoc basis pending finalization of the relevant rules governing sanction of Adhoc Grant-in-Aid to the respective colleges.
- vi. That the statement of expenditure of the grant and utilization certificate should be furnished by the institution to the Director of Higher & Technical Education. The amount sanctioned shall be utilized solely for the purpose for which it is sanctioned. Any unspent amount shall be intimated to the Director of Higher & Technical Education for refund.
- vii. That the accounts of the college shall be opened to audit by the Director Local Fund Audit or any agency authorized by the Government.
- viii. That the approved sanction is towards supplementing the pay and DA only of the sanctioned posts at Government approved rates and the Governing Body shall ensure that the minimum of State Scale of Pay (basic + DA) is disbursed to the respective employees.
- ix. That the approved sanction shall be only for full time staff entertained as per qualifications prescribed by the University and for courses for which the University has granted affiliation.
- x. That the college shall abide by relevant Government instructions issued from time to time.
