Sir,

On the above subject and in pursuance to letter dt. 15/01/2020 under reference, a spot enquiry in respect of Tura Town Hr. Secondary school, Tura related with the recruitment of Office Asst. in the year 2018 was conducted on the 4th/Feb.,2020 at 12 O'Clock in the presence of Shri. S S. Bhattacharjee, Secretary Managing Committee and Vice Principal Mr.Rajib Deb of the said school. After a detail discussion with the school authority and verification of facts and documents available in the O/O The DSEO,Tura a brief report is detailed below :-

1. The advertisement for the vacant post of office Assistant(Deficit) in the Secondary Section of Tura Town Hr. Secondary School, Tura was made in the month of July, 2018 by the District School Education Officer, West Garo Hills, Tura as the School Managing Committee was at that time under suspension and the District School Education Officer, West Garo Hills, Tura was the Head/Administrator of the school and managed the school affairs

As per instruction from the D.S.E.O., Tura the written Test for the post of Office Assistant was conducted in the school on 19.09.2018. 72 (Seventy two) candidates appeared the Written Test and Out of these , candidates who secured minimum 30 Marks were called for viva-voce conducted in the O/O the D.S.E.O., Tura on 22.11.2018.

On the basis of the above Interview, proposal for approval was submitted by the DSEO, Tura to the Directorate of School Education & Literacy, Meghalaya and after approval from the Directorate, Shri Shantanu Chakravarty, 1st position holder in the interview has been appointed in the post of office Assistant in the Secondary Section of the said School.

2. According to the complaint raised by Shri. Monik Modak(3rd position) in the list of successful candidates , the main issue related with the above recruitment and appointment of Shri. Shantanu Chakravarty, the 1st position candidate is that the above said candidate was overaged as per Govt. rules. In this regard, it is felt necessary that the application and documents submitted by Shri. Shantanu Chakravarty be scrutinized to ascertain the above allegation as given below :-

(a) As per the Admit Card & SSLC Certificate issued by the M.B.O.S.E, Tura the date of birth of Shri. Shantanu Chakravarty is 30.11.1985. If calculated at the time of recruitment in November, 2018, his age was 32 (Thirty two) years.

(b) As per Govt. rules the age limit for employment in Govt. offices/ Institutions is 18 to 27 (General candidate) plus 5 years relaxation for SC/ ST candidates i.e 32 years.

(c) As per the Meghalaya Fundamental Rules and Subsidiary Rules, 1985, S.R. 6 (iv) the age limit for employment in Govt. aided schools is 35 years provided the candidate is eligible and have acquired necessary experience.

(d) As per advertisement floated in the Shillong Times during the month of July 2018, it was clearly mentioned that candidate should be within the prescribed age limit as admissible under the rules and candidates already employed should apply through proper channel.

(e) When Shri Shantanu Chakravarty submitted his application for the post of Office Assistant at Tura Town Hr. Secondary School, Tura, he was working in the Office of Project Director, D.R.D.A. and Addl. District Programme Co-ordinator, MGNREGS, Meghalaya, West Garo Hills for a period of 8 (eight) years w.e.f 17.6.2011 duly forwarded through proper channel by the Project Director, DRDA, Tura.

3. Views and Comments – On the above facts highlighted at Para 1 & 2(a,c,d & e), the allegation that the age of the candidate Shri Shantanu Chakravarty who stood first in the interview was overaged is not true and not based as per the existing Govt.rules in force.

Secondly, the date of birth of any candidate for recruitment in Govt. establishment is usually based on the date recorded in the SSLC (Matric) Certificate issued by the recognised Boards not from any other sources.

Thirdly, other allegations against the school authority of Tura town Hr. Secondary School, Tura is also found to be baseless as the Interview was conducted by the concerned authority under the supervision of the DSEO, Tura

This is for favour of information and necessary action.
