OFFICE MEMORANDUM

Dated Shillong the 13th August, 2013

No.EDN. 30/2010/61 :- In the interest of administrative expediency and for effective supervision of all activities and programmes being implemented in the School Sector, the Department of Education, Government of Meghalaya has completed the GIS Mapping of all functional Schools in the state where the stated objectives were achieved, viz:

- 1) Completion of GIS Mapping of all functional Schools (Elementary up to Higher Secondary level) located in the Districts of Meghalaya.
- 2) To plot longitude – latitude positions of each School on digitized maps and integrate with other non-spatial data available in UDISE data and other data sources so as to prepare a data base on a GIS platform.

Subsequently, the GIS Application FOR Schools was further developed by NIC, Meghalaya in collaboration with NIC, Andhra Pradesh.

The Protocol for utilizing the GIS Map and related applications is defined as below:-

1. The rights to the GIS Application for Schools shall vest with the Education Department, Government of Meghalaya.
2. Any agency/ department who desire to utilize the data shall obtain formal permission from the Education Department.
3. The GIS Application of Schools will be hosted in NIC, Andhra Pradesh, until such time as and when NIC Meghalaya acquires their own GIS server.
4. The application for the Education Department shall be role based. A separate interface will be provided for citizens in the Education Portal of Meghalaya who will not require any login accounts.
5. The Role of Administrator shall be reserved for the Project Coordinator, GIS Mapping of Schools, NIC Meghalaya and the Systems Analyst SEMAM (SSA), Shillong. The administrator will create user accounts for the Officers of the Education Department for accessing the GIS application.
