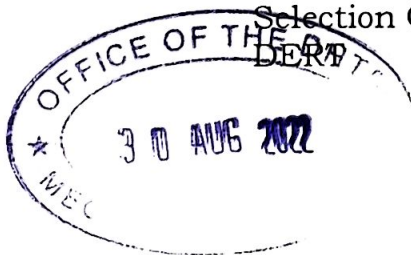

7. To ensure regular training of Teachers/ School Heads/ SMCs/ SDMC members, BRCs/ CRC and other stakeholders in the aspects specified by the FLN Mission.
8. To implement IT based solutions/ MIS/ e-governance for school related administration work.
