In pursuance of the NEP 2020 and with the aim of improving the overall quality of school education in the State, it is hereby notified that all schools in Meghalaya are to strictly implement the Meghalaya School Quality Assessment and Accreditation Framework (MSQAAF) developed by the Directorate of Educational Research and Training (DERT), Government of Meghalaya.

Key Directives:

1. All schools are directed to download the MSQAAF and Guidelines For Self Assessment from the Education Website.

2. The Meghalaya Information School Management System portal has been developed and is available @ (<https://meghsims.com/>)
3. All Schools are required to go through the framework, Guidelines and conduct the self-assessment in the **meghsims** portal only.
4. A tutorial on using the portal and the framework is available in the DERT YouTube channel.

5. Schools must develop and implement School Improvement Plans based on MSQAAF feedback and prioritizing.
6. The Meghalaya School Standards Authority (MSSA), will conduct external evaluations and accreditation of Schools once in 3(three) years.
7. All schools must adhere to the MSQAAF guidelines and standards.

Implementation Timeline:

8. All schools must familiarize themselves with MSQAAF and the portal and register within the next 4 (four) weeks.
9. Self-assessment reports must be filled using the portal and completed by 30th September, 2025.

Consequences of Non-Compliance:

10. Failure to comply with this notification may result in accreditation status being withheld or revoked or de-recognition of the school.

Support and Resources:

1. Meghalaya School Standards Authority will provide training and support to schools to ensure effective implementation.
