Quotations received after due date and time either by hand or by post will be rejected.
- 8. You shall submit only one set of quotations for the above items. Your quotation must be typed or written in indelible ink and shall be signed by you or your authorized representative. Without a signature in your Form of Quotation, your quotation will not be considered further.

- 10. Your quotation(s) should be submitted as per the following instructions and in accordance with the attached form of Contract. The attached Terms and Conditions of Supply is an integral part of the Contract.
 - i) **Prices:** Prices shall be quoted in the currency of the Purchaser.
 - ii) Evaluation of Bid: The Purchaser will evaluate and compare only the quotations determined

to be substantially responsive. In evaluating the quotations, the Purchaser will adjust for any arithmetical errors as follows:

- a. Where there is a discrepancy between amounts in figures and in words, the amount in words will govern;
- b. Where is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern; and
- c. If a Supplier refuses to accept the correction, his quotation will be rejected. In addition to the quoted price, the evaluated price shall include Goods & Services Tax (GST) in India.
- iii) Award of Supply Order: The award will be made to the bidder offering the lowest evaluated price and that meets the required standards of technical and financial capabilities. The successful bidder will sign a Contract as per attached form of contract and Terms and Conditions of supply.

 - c. Should have facility to organize/provide after sales service support.
 - d. Supplier must have GST Registration, Service Tax Registration, PAN/TAN number, VAT clearance certificate etc.

- 1. The said Items shall be supplied in compliance to the specifications as mentioned at Annexure-A.
- 2. The specifications of the Items as mentioned at Annexure-A are the requirements, however higher specifications of Desktop Computers, laptops, printer with scanner etc., may be considered subject to their cost economics i.e. competitiveness in financial terms for the particular location.
- 3. After the supply of said Items as mentioned at Annexure-A, the supplier has to execute its installation & commissioning at the designated site in the location(s). No extra cost shall be paid for this reason.
- 4. The purchaser interested for complete delivery of said IT Equipments by the supplier within sixty (60) calendar days from the date of issue of supply order.
- 5. The material shall be inspected on receipt at site and supplier shall be responsible for any damage during the transit of equipments.
- 6. The supplier shall offer on-site comprehensive 3 years warranty for Desktop Computers, 1 year for Laptops, 2 years for UPS, 1 year each for Printer, 720p HD Webcam, Speaker, Wifi Router, Wifi Extender and 3 years for Internet Security software for 1 user from the date of successful installation at the designated location & shall cover each and every part of the Desktop Computers, Laptops etc., including parts having limited life. The purchaser is not liable to pay any extra charges on any account during warranty period excluding softwares like Operating Systems.
- 7. Any part or parts fail or proved defective within the on-site warranty period specified above, owning to defect in design, material or workmanship, the supplier shall have to replace them at the place of installation without asking for any charges.
- 8. During the warranty period, expert(s) shall be deputed at site by the supplier within three working days from the date of request from purchaser, to rectify and fixing the defects of Desktop Computers, Laptops, UPS at the location where supplied. The cost of deputation of expert(s) and any other associated expenditure shall be borne by the supplier excluding softwares like Operating Systems.
- 9. The supplier shall ensure to render after sales services during the warranty period to the satisfaction of purchaser.
- 10. The supplier will depute their engineer within three (03) working days to attend the service call received in writing from purchaser.
- 11. The person signing the form or any other documents on behalf of the Supplier shall be deemed to warrant that he has authority to bind the Supplier. If it subsequently comes to light that the person so signed had no authority to do so, the purchaser may without prejudice to any other civil & criminal remedies cancel the tender and hold the Supplier liable for all costs, charges and damages.
- 12. The Price of said Items as mentioned at Annexure-A shall remain firm & inclusive of all costs involved for the delivery to the destination(s) which include the cost of Installation at destination, Cost of services to be provided during Comprehensive Warranty of three years.
- 13. No extra payment or revision of "Price of said Items at Annexure-A before Taxes & Duties" shall be accepted on account of any discrepancy in nomenclature of items. The Supplier is advised to seek clarification, if any, desired before submitting the quotation.
- 14. The supplier shall provide packing of the said Items at Annexure-A, as is required to prevent their damages or deterioration during the transit to their final destination. The packing shall be sufficient to withstand, without limitation, rough handling during transit. In case the consignment received with damaged packaging, the purchaser would not accept the delivery.
- 15. The said Items at Annexure-A shall be securely boxed, crated and protected from mechanical damage, moisture etc. suitable for both storage and transit according

to the nature of the material and mode of transport.

- 16. The successful Supplier shall, within of а week from the date receipt of communication of acceptance of quotes from purchaser shall intimate his The shall acceptance of the order. supplier complete supplies strictly as per the accepted delivery period.
- 17. The 100% payment of total bill will be made by the purchaser by crossed account payee cheque/RTGS/NEFT for which the supplier shall send bills in triplicate after complete Supply & Installation of materials as mentioned at Annexure-A giving the reference number of the purchase order along with copies of delivery note & satisfactory report on the Installation of Desktop Computers etc., from designated purchaser department. The details about the designated purchaser department who is authorized to take the delivery of Desktop Computers shall be informed to the successful supplier through the supply order to be place.
- 18. While submitting the quotation, if any of the prescribed conditions are not fulfilled or are incomplete in any form, it is liable to be rejected.
- 19. If the specification of supplied said Items at Annexure-A are found to be lower than those stipulated in the accepted offer, the purchaser shall have right to totally reject the supplied said Items at Annexure-A and to claim for compensation from supplier. The supplier shall reimburse to purchaser, the claim lodged in writing within 15 (fifteen) days of its demand.
- 20. The supplier shall be responsible for arranging the rejected Desktop Computers to be removed at his cost from purchaser premises.
- 21. Authorized Service Centre should be available locally.
- 22. Bid specific Authorization Certificate with OEM representative name, address, phone no, emailid should be provided.
- 23. CPU Cabinet, Keyboard, Mouse, Monitor should be of the same logo/make.
- 24. The Undersigned reserve the right to cancel or postpone the RFQ at any given day and time (but not after issuing official supply order).
- 25. The Contract shall be interpreted in accordance with the laws of the Purchaser's country and State.
- 26. The Purchaser and the Supplier shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute between them under or in connection with the Contract. In the case of a dispute between the Purchaser and the Supplier, the dispute shall be settled in accordance with the provisions of the State of Meghalaya (arbitration law or rules of the Purchaser's country).
- 27. The supplier shall not be liable for penalties or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

For purposes of this clause, "Force Majeure" means an events beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but not restricted to, act of Purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.

If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by Force Majeure event.
