Sir,

Please find enclosed a copy each of English and Hindi version of the Notifications (No.19012/01/2017-Edu dated 30.5.2017) published in Extraordinary Gazette of India (Annexure-I) in respect of following 5 schemes of Ministry of Tribal Affairs, under Section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 for necessary action:-

- i) Scholarships including Pre-Matric, Post-Matric, National Fellowships & Scholarships, and scholarships for studying abroad
- ii) ✓ Scheme of Grant in aid to Voluntary Organizations working for the welfare of STs
- iii) ✓ Vocational Training in Tribal Areas
- iv) ✓ Institutional Support for Development and Marketing of Tribal Product.
- v) Development of Particularly Vulnerable Tribal Groups (PVTGS)

2. It is requested that wide publicity through media and individual notices may be given to the beneficiaries to make them aware of the requirement of Aadhaar to receive benefits under the Schemes and they may be advised to get themselves enrolled at the nearest enrolment centre available in their local areas by 30th June 2017 in respect of schemes at Sl.No. (i) to (iv) above, and by 30th September 2017 in respect of scheme at Sl.No.(v) above, in case they are not enrolled.

3. The notification is applicable in all the states and UTs except the states of Assam, Meghalaya and Jammu & Kashmir.

4. It is also requested that instructions issued by UIDAI with regard to Do's and Don'ts regarding usage of Aadhaar data (enclosed as Annexure-II) may be adhered to in letter and spirit to ensure security and privacy of UID data.
