On behalf of the Education Department, Govt. of Meghalaya, applications are invited through online mode only from citizens of India who are permanent residents of Meghalaya as per the terms and conditions of this advertisement for recruitment to the post(s) mentioned below: -

It is mandatory for the applicants to have acquired the requisite Educational qualification(s) & Professional qualification(s) prescribed for the post(s), as on the last date fixed for submission of applications.

The date on which an applicant is deemed to have acquired the requisite educational & professional qualifications shall be the date on which the result of the last examination for such qualification/degree is declared by the Universities/Boards/ Institutions.

Online Applications will be received w.e.f. 19th December, 2025 upto 08th January, 2026 and no application will be entertained after the closing date.

Applications are invited from candidates who are citizens of India (as defined under Articles 5-8 of the Constitution of India) who are permanent residents of Meghalaya for appointment to the under mentioned posts in the Directorate of Educational Research & Training (DERT) and the District Institutes of Education & Training (DIETs), Meghalaya

- (i) **In case there are no candidates obtaining the prescribed professional qualification at the time of advertisement, he/she has to obtain the required professional qualification within eight (8) years from the date of joining for future placement.*
- (ii) *Professional Qualification like D.El.Ed/ B.Ed/ M.Ed should be NCTE recognized. For D.Ed(Special Education) / B.Ed(Special Education) and M.Ed (Special Education) it should be approved by RCI.*

PARA 2: AGE & AGE RELAXATION- A candidate must have attained the age of 18 years and must not have exceeded the age of 32 years as on 01.01.2025. The upper age limit is relaxed by 5 (five) years in case of candidates belonging to SC/ST. No age bar in respect of regular government employee who entered govt. service within the prescribed age limit.

The date of birth to be accepted by the Board is as entered in the Matriculation/ Secondary School Leaving Certificate or birth certificate from the official Registers duly certified by the government authority. Documents other than these will not be accepted by the Board.

PARA 3: APPLICATION FEE (NON-REFUNDABLE)

Fee as prescribed in the Table below is required to be paid through **online mode**.

PARA 4: SUBMISSION OF ONLINE APPLICATION

Candidates are to apply and submit their applications through online mode by clicking on the “Online Application” icon appearing in the Education Department website viz. www.megeeducation.gov.in. Applications received through any other mode will not be accepted and will summarily rejected.

Kindly read the instructions on the web page carefully before applying. Online Applications will be received w.e.f. 19th December, 2025 upto 08th January, 2026 and no application will be entertained after the closing date.

PARA 5: PAYMENT OF APPLICATION FEE

Payment shall be made through **Payment Gateway** available in the portal.

PARA 6: METHOD OF SELECTION

Only Candidates who have uploaded all the required documents relating to their educational and professional qualification, date of birth, caste, community and other

necessary information wherever required and prescribed will be screened and deemed qualified to be called for the Written Examination/ Personal Interview.

The Final selection / recommendation of suitable candidates against the vacancies notified in this Advertisement shall be made by the Recruitment Board.

PARA 7: INSTRUCTIONS

- (i) Applicants are advised to apply well in advance without waiting for the closing date.
- (ii) Candidates, if found not eligible, can be rejected at any stage of the Recruitment Process. Admission to the recruitment process for which the candidates are admitted by the Board will be purely **provisional** subject to satisfying the prescribed eligibility conditions.
- (iii) Applicants are advised to ensure their eligibility with regard to the educational and professional qualification(s), age and other criteria as required for the post. If an applicant is found not fulfilling any of the eligibility conditions, at any stage of the recruitment process and including the last stage of process of recruitment i.e., "Recommendation", the candidature for the post shall be automatically cancelled by the Board without notice.
- (iv) PwD candidates: Person defines under OM No. PER (AR) 150/88/534 Dt. 07/08/2017 are considered PwD candidate and must possess a Disability Certificate issued by the Competent Authority.
- (v) A candidate must appear for the Written Examination/ Personal Interview at his/her own expenses.

PARA 8: RECRUITMENT BOARD'S DECISION ON ELIGIBILITY OF CANDIDATES

While submitting the applications, a candidate has to satisfy that he/she is qualified in accordance with the condition of qualification for the post applied. If he/she is not qualified, his/her candidature shall be summarily rejected/ disqualified at any stage of Selection process (Selection Process which includes Screening/ Written Examination/ Personal Interview/Recommendation etc.). Suppression of any information or giving false information shall invite penal action which may lead to barring the candidate from appearing in future recruitment.

Candidates are advised to ensure that he/she is qualified to the post advertised in all respects. However, if the candidate is **NOT FOUND QUALIFIED** at any stage of the recruitment process, his/her candidature shall be rejected/cancelled forthwith. Therefore, candidates are advised to check their **ELIGIBILITY** carefully before applying for the post.

PARA 9: DEBARMENT

- a) Candidates should make sure of their eligibility for the post applied for. Any candidate furnishing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable **'TO BE DEBARRED FROM APPEARING FOR ANY OF THE EXAMINATIONS CONDUCTED BY THE BOARD'**, and subsequently their candidature for this recruitment will be rejected.
- b) Candidates found using unfair/illegal means during the conduct of the recruitment process will be debarred from appearing in the written examination/personal interview conducted by the Board.
- c) The Recruitment Board is vested with the constitutional duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by anyone causing or likely to cause breach of this constitutional duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by the Board will cause for rendering such questionable means as ground for debarment.
- d) If any candidate is or has been found impersonating or procuring impersonation by any person or resorting to any other irregular or improper means in connection with his/her candidature for selection or obtaining support of candidature by any means, such candidate may in addition to rendering himself/ herself liable to criminal offence, will be liable to be debarred permanently from any examination or selection held by the Meghalaya Education Recruitment Board (MERB).
