1. Chemical Engineering.
2. Electronics and Communication.
3. Electronics and Telecommunication.
4. Industrial Electronics.
5. Textile Process.
6. Printing Technology.
7. Man Made Fibre Technology.
8. Pharmacy.

**Admission Qualification:-**

Students must have passed SSLC/HSLC Examination or equivalent with Mathematics and Science from any recognized Board of School Education in India. Candidates passed in the Supplementary Examination are not eligible for admission.

**Candidates securing less than 40% marks (for SC, ST, OT Category) and 50% marks (for General Category) in any of the subjects in SSLC/HSLC Examination or in equivalent examination need not apply and such candidates will not be considered in the merit list for allotment of seats for admission to Diploma course in Engineering/Technology. The allotment of seats will be done as per the merit marks subject to the fulfillment of eligibility criteria of the concerned institutions where the seats are reserved.**

Class XII Examination or equivalent examination passed candidates with PCMB may apply for the above course at Sl.8 where the admission qualification is passing of Class XII/ Equivalent Examination.

**Candidates securing less than 40% marks (for SC, ST, OT Category) and 50% marks (for General Category) in any of the subject i.e. Physics, Chemistry and Mathematics/Biology need not apply and such candidates will not be considered in the merit list for allotment of seats in Diploma course in Pharmacy. The allotment of seats will be done as per the merit marks in PCB for admission to diploma course in Pharmacy subject to the fulfillment of eligibility criteria of the concerned institutions where the seats are reserved.**

Application forms can be obtained from the Office of the undersigned (**Room No: 129, Additional Secretariat Building**) from **23<sup>rd</sup> May 2013** onwards on payment of application fee of **₹10/-** by crossed **Indian Postal Order** payable in favour of the Director of Higher & Technical Education, Meghalaya, Shillong.
