Applications in the prescribed forms are invited from the candidates who are permanent residents of Meghalaya for admission to four year's **B.Sc (Forestry) Course for the academic session 2013-2014 against 1 (one) seat reserved by Dr. Y.S. Parmar University of Horticulture and Forestry, Nauni, Solan, Himachal Pradesh under NEC quota.** Applicants should note that no financial assistance shall be provided by NEC in connection with the Degree course.

Applicants may make an online submission of application form by accessing the **Website <https://www.meghalayaonline.gov.in> or [www.megeeducation.gov.in](http://www.megeeducation.gov.in).** The candidates must provide all details while filling up the online application as per instruction sheet. Candidates are required to take a printout of the completed online application after successful submission of data. The printout of the computer generated application form in duplicate completed in all respects is to be submitted on or before **21<sup>st</sup> June 2013** during Office hours to the Office of the Director of Higher & Technical Education, Meghalaya, Shillong (**Room No: 129, Additional Secretariat Building**).

The duplicate form duly completed should also be submitted for record.

**EDUCATIONAL QUALIFICATION:**

The eligibility criteria for admission to the above course is 10+2 or any other equivalent examination with English, Physics, Chemistry, Biology/Mathematics/Agriculture of a recognized University/Board with a minimum of 50% aggregate marks (45% for ST/SC) in the above mentioned subjects. Selection of candidate shall be made in order of merit of aggregate marks in English, Physics, Chemistry and Biology in the qualifying examination.

**AGE LIMIT:**

Candidates should not be less than 17 years and not more than 21 years of age as on 1<sup>st</sup> July 2013. The upper age limit is relaxable by 3 years in case of candidates belonging to Scheduled Tribe and Scheduled Caste.

**RESERVATION:**

Nomination of selected candidate in order of merit will be made from this Office against the above seat. **The reservation policy of the State Government will be applicable.**
