Applications in the prescribed forms are invited from the candidates who are permanent residents of Meghalaya and have passed Higher Secondary (10+2) or any other Equivalent Examination and appeared in JEE (Main) - 2013 for admission to Colleges outside Meghalaya having **Engineering/Technology and Pharmacy Degree Courses** during the session **2013-2014** against seats to be allotted by the Govt. of India.

Online Application

Applicants may make an online submission of application form by accessing the **Website https://www.meghalayaonline.gov.in**. The candidates must provide all details while filling up the online application as per instruction sheet. Candidates are required to take a printout of the completed online application after successful submission of data. The printout of the computer generated application form in duplicate complete in all respects is to be submitted on or before 19th June 2013 during Office hours to the Office of the Director of Higher & Technical Education, Meghalaya, Shillong (Room No: 129, Additional Secretariat Building). Applicants from Garo Hills may submit the above at the Office of the Principal, Tura Government College, Tura.

Offline Application

Application forms in duplicate can be obtained from the Office of the undersigned (Room No: 129, Additional Secretariat Building) from 30th May 2013 onwards. Application forms in duplicate may also be downloaded from the Meghalaya Govt. Website www.meghalaya.nic.in or www.megeducation.gov.in. Application form duly completed in all respects is to be submitted on or before 19th June 2013 during Office hours to the Office of the Director of Higher & Technical Education, Meghalaya, Shillong (Room No: 129, Additional Secretariat Building). The duplicate form duly completed should also be submitted for record. Applicants from Garo Hills may submit the above at the Office of the Principal, Tura Government College, Tura.

Screening will be conducted on 15th July 2013 at 10:30 AM in Pine Mount School Auditorium, Shillong and on 12th July 2013 at 10:30 AM in Tura Govt. College, Tura. Applicants are required to appear before the Screening Committee as per the schedule stated above for verification of all the original documents. Travelling expenses for the interview will need to be borne by the candidates themselves.

EDUCATIONAL QUALIFICATION:

- 1. For Engineering/Technology courses, the candidates must have passed Class XII (Science) Examination or Equivalent Examination from any recognised Board of Higher Secondary Education/University in India with Physics, Chemistry and Mathematics (as well as in Biology for certain States) as the subjects of Examination and must have appeared in JEE (Main) 2013.
- 2. For Pharmacy course, the candidates must have passed Class XII (Science) Examination or Equivalent Examination from any recognized Board of Higher Secondary Education/University in India with Physics, Chemistry and Biology as the subjects of Examination.

ELIGIBILITY:

1. Entry to Engineering/Technology courses:

The selection of candidates and allotment of seats for Engineering/Technology courses will be based in order of combined merit marks i.e. 40% weightage for performance in Class XII Board marks normalized on percentile basis and the remaining 60% weightage would be given for the performance in JEE (Main) Examination and the combined merit list would be decided accordingly.

- N.B. 1. Candidates who have not appeared for JEE (Main) 2013 need not apply.
 - 2. Candidates who were nominated and have accepted nomination in previous years shall not be considered for allotment of seats.

2. Entry to Pharmacy course:

The Selection of candidates and allotment of seats for Pharmacy course will be based on the merit marks of Physic, Chemistry and Biology.

Candidates intending to undergo Engineering/Technology/Pharmacy courses must produce Marksheets, Caste/Tribe Certificates, Birth Certificate PRC, Score Card of JEE (Main) - 2013 etc in original before the Screening Committee.

AGE LIMIT:

Candidates should not be less than 17 years and not more than 21 years of age as on 1st July 2013. The upper age limit is relaxable by 3 years in case of candidates belonging to Scheduled Tribe and Scheduled Caste and 1(one) year in case of B. Sc, passed candidates.

RESERVATION:

From the number of seats to be allotted by the Govt. of India to the State of Meghalaya, the reservation of seats shall be based on the existing policy of the Govt. of Meghalaya.
