**Eligibility Criteria:**

Candidates must have Passed 10+2 or Equivalent Examination in any discipline from any recognized University/Board with minimum 45% marks (40% for ST/SC). Selection of candidate shall be made in order of merit of aggregate marks in the qualifying examination.

Candidates must have Passed 10+2 or Equivalent Examination in Science subjects from any recognized University/Board with minimum 45% marks (40% for ST/SC) for Audiography and Sound Engineering. Selection of candidate shall be made in order of merit of aggregate marks in the qualifying examination.

**AGE LIMIT:**

Candidates should not be less than 17 years and not more than 24 years of age as on 1<sup>st</sup> July 2024. The upper age limit is relaxable by 3 years in case of candidates belonging to Scheduled Tribe and Scheduled Caste.

**RESERVATION:**

Nomination of selected candidate in order of merit will be made from this Office against the above seat. The reservation policy of the State Government will be applicable.
