Eligibility criteria for admission to other B. Tech Programme is 10+2 or any other equivalent examination with aggregate of compulsory subjects along with Physics, Chemistry, Mathematics of recognized University/Board with a minimum of 45% for General category and 40% in case of ST/SC category.

Nomination of selected candidate in order of merit will be made from this Office against the above seat. The reservation policy of the State Government will be applicable.


