The eligibility criteria for admission to B.Tech. (Agricultural Engineering and Food Technology) is passed HSSLC (10+2) or Equivalent Examination with minimum 50% marks in aggregate of PCM/PCMB for General and OBC(NCL)EWS Categories and 40% marks for SC/ST/Third Gender/PwD/In-service Categories.

The eligibility criteria for admission to B.Sc. (Hons) (Community Science and Food Nutrition & Dietetics) is passed HSSLC (10+2) or Equivalent Examination with minimum 50% marks in aggregate of PCB/PCBM/PCM for General/OBC(NCL)/EWS Categories and 40% marks for SC/ST/Third Gender/PwD/In-service Categories.

The eligibility criteria for admission to B.Sc. (Hons) in Forestry is passed HSSLC (10+2) or Equivalent Examination with minimum 50% marks in aggregate of PCB/PCMB/Inter-Agriculture for General/OBC(NCL)/EWS Categories and 40% marks for SC/ST/Third Gender/PwD/In-service Categories.

## **AGE LIMIT:**

Candidates must have attained 16 years of age as on 31st August 2025.

Nomination of Selected candidates in order of merit will be made from this Office against the above seats. The reservation policy of the State Government will be applicable.
