**SCHEME OF MERIT-CUM-MEANS BASED SCHOLARSHIP FOR STUDENTS BELONGING TO THE
MINORITY COMMUNITIES**

Applications in prescribed format are invited from the students belonging to the Minority Communities i.e. Muslims and Christians pursuing Technical or Professional Courses (at Graduate/Post Graduate level) in an institution recognized by an appropriate authority for Merit-Cum-Means Based scholarship for the year 2010-2011 to be awarded by the Ministry of Minority Affairs, Government of India.

Students who have got admission in a recognized college to pursue Technical/Professional Courses without facing any competitive examination will also be eligible for Scholarship. However such students should have not less than 50% marks at Higher Secondary/Graduation level. Selection of these students will be done strictly on merit basis.

A scholarship holder under this scheme will not avail any other scholarship/stipends for pursuing the course.

The annual income of the parents or guardian of the beneficiary should not exceed of Rs. 2.50 lakhs per annum from all sources.

The students should produce the Permanent Residential Certificate obtained from the concerned Deputy Commissioner of the District in which a candidate is a Permanent Resident of Meghalaya along with all the Certificates/Marksheets etc. and the students should also produce a certificate showing that he/she belongs to the specified Community. The last date for submission of Application with all relevant documents is on or before 30th June 2010. No application will be entertained after the above specified date
