3. The Govt. of India may deploy senior Officers (not below the rank of Joint Secretary level) as Nodal Officer, working in two-members team comprising one State and one Govt. of India Officer and inspect schools in low performing Districts.
4. All selected PM-SHRI Schools shall be evaluated and graded against defined parameters within three months and every sector and every state must develop such model institution, whether in infrastructure or service delivery to drive systematic improvement.
