No.EDN/RTE-219/2011/40:- In pursuance of Clause(b) of Sub-Section-(2) of Section 13 of the Right of Children to Free and Compulsory Education (RCFCE) Act, 2009, the State Government do hereby prohibits screening procedure i.e. any test or interview/interaction of the child or interview/interaction of the parents for admitting a child to any school including private schools. Only random procedure shall be used for admitting a child to school. This prohibition would apply to all schools as per clause (n) of Section 2 of the aforesaid Act.

Anyone who subjects a child to any form of screening procedure shall be punishable with fine up to 'Rs.25,000 (Rupees Twenty Five Thousand) for the first contravention and 'Rs.50,000 (Rupees Fifty Thousand) only for each subsequent contraventions.
