Terms of Reference:-

The Core Group will recommend Subject Groups (Social Sciences, Sciences, Mathematics & Languages) for Syllabus and Textbook Review. Such groups should be constituted separately for Primary, Upper Primary, Secondary and Higher Secondary level. The Core Group will ensure that the State Syllabi are revised to .-

(1) incorporate the values enshrined in the Constitution of India

- link school knowledge in different subjects and children's everyday experiences.*
- see that contents included in textbooks be at par with that of the rest of the country.*
- ensure appropriateness of topics and themes for relevant stages of children's development*

- *ensure continuity from one level to the next.*
- *reflect sensitivity to gender, caste and class parity, peace, health and needs of children with disabilities.*
- *make inter-disciplinary and thematic linkages between topics listed for different school subjects, which fall under discrete disciplinary areas.*
- *infuse environment related knowledge and concern as well as work related attitudes in all subjects and at all levels.*
- *nurture aesthetic sensibility and values by integrating the arts and India's heritage of craft in every aspect of the curriculum.*
- *utilise the potential of educational technology, and include all other new technologies in all subjects.*
- *encourage flexibility, epistemic activism and creativity in all areas of knowledge and its construction by children.*
- *Attempt to see that the syllabi is made relevant and contemporary for the student community.*
