7. Supervision of the Grievance Redressal Mechanism.
8. Organization of awareness and publicity drives amongst stakeholders.
9. Coordination with Deputy Commissioners, Supply Department, FCI and DSE&L.
10. Coordination with MHRD, GOI on all outstanding matters.
11. Supervise preparation of Annual Work Plan & Budget and to represent State Government in PAB meetings.
